Customer Declaration

We hereby make our amendments as indicated on page 1 of this application in reference to the facility agreement granted to us for the issuance of guarantees (hereinafter referred as "Facility Letter").

In consideration of your request or your correspondent bank's request (at your behest), we hereby agree to amend our bank guarantee, tender bond / bid bond, performance bond, advance payment bond, retention bond or any other form of guarantee as provided by the Bank ("hereinafter referred as "Guarantee") pertaining to the expiry date, guaranteed amount, beneficiary details or other guarantee details (hereinafter referred as "Amendment").

We do not require you to obtain confirmation from the beneficiary under the Guarantee of its acceptance of the terms of the Amendment and will not hold you liable for any loss, damage and/or cost suffered or incurred by us arising or in relation thereto.

Without prejudice to any term in the Facility Letter, we hereby agree that we shall fully indemnify and hold you harmless from and against all claims, demands, actions, damages, costs, losses, expenses or other sums which you may incur or pay by reason of or in connection with the Guarantee and/or the Amendment and we shall pay to you upon demand all such sums.

Where the Guarantee allows for automatic extension of the expiry date and the Amendment is made in relation to our request to amend the expiry date or terminate the Guarantee contrary to the terms of the previously issued Guarantee, we are fully aware that the beneficiary has the right to insist that the original expiry date stated in the Guarantee still applies and that the requisite notice for amendment or termination is to be given in accordance with the original terms of the Guarantee.

We are fully aware that this may lead to the Guarantee being extended for a longer period than we have amended, instructed or intended and undertake to pay all applicable charges and fees in relation to the Guarantee for such extended period.

Our liability to indemnify you as aforesaid up to the full amount claimed by the beneficiary under the terms of the demand made under the guarantee, shall not be reduced or affected whatsoever in the event that the beneficiary claims that the Amendment is not effective at law or the beneficiary otherwise makes a claim under the Guarantee without taking into account the terms of the Amendment.

We further agree that whenever you pay any sum to the beneficiary pursuant to a claim, you shall have the right, by notice to us, to be immediately reimbursed in an amount equal to, and in the currency of, the sum so paid.
