## Subject: Closure of Mizuho Bank, Ltd.'s SGD and USD Cheque Deposit Services

We refer to the above caption.

In line with the Singapore government's initiative on transforming Singapore into a Smart Nation, the Monetary Authority of Singapore ("MAS") has made a public announcement on 28 July 2023 to eliminate corporate cheques by end-2025.

In line with this MAS initiative, Mizuho Bank, Ltd., Singapore Branch (the "Bank") will cease its cheque deposit operations and services for Singapore Dollar ("SGD") cheques and United States Dollar ("USD") cheques with effect from 1 May 2024.

Accordingly, please notify your respective suppliers/vendors/clients to send their payments to the Bank through electronic channels such as FAST, GIRO, MEPS for your SGD deposits and Remittance telegraphic transfer for your USD deposits. Enclosed below is a list of frequently asked questions ("FAQs") which you may find useful.

A2) 30th April 2024 (Thursday), last cutoff time is at 2:00 p.m. (SGT)
